# INTRODUCTION

The Mission of Sustainable Development Goals Coordination Centre (SDGCC) in Haryana is to be instrumental in fostering sustainability and achieving the UN's Sustainable Development Goals (SDGs) by empowering the state with transformative resources that fulfil its human, financial, system, data and information needs. Initiated through a partnership with the United Nations Development Programme in 2018 and housed under the Swarna Jayanti Haryana Institute for Fiscal Management (SJHIFM), the SDGCC strategically coordinates efforts across various policy domains to ensure holistic development and achievement of SDGs in the state of Haryana.

The Government of Haryana took a pioneering step in 2017 to become the first ever state in India to formulate its SDG VISION 2030. Giving practical shape to the State VISION 2030 and implementing various innovations planned under the Vision document, SDGCC initiated the process by aligning disparate departments and their schemes towards specific SDGs. SDGCC has been pivotal in driving a paradigm shift, encouraging departments to adopt comprehensive, SDG-specific approaches. The centre established a platform for continuous monitoring through dashboards, indices, and reports to empower policymakers with real-time insights.

Recognising the importance of shared understanding, SDGCC prioritised sensitisation beyond numerical targets to demonstrate how SDGs positively impact lives, supporting the Finance and Planning Department in implementing innovative budgetary policies to ensure transparent benefit distribution. The centre's impact is evident in developing progress indices at various levels, translating SDGs into measurable outcomes.

SDGCC operates as a catalyst for change through awareness programs, capacity-building initiatives, and data analyses. With a purpose-driven vision, SDGCC contributes to the well-being of citizens and the global aspiration for a sustainable future.





### **Pioneering Collaboration:**

Haryana envisioned a future replete with sustainability, driven by the global call to action encapsulated in the Sustainable Development Goals (SDGs). To turn the vision into reality, it established India's first ever Sustainable Development Goals Coordination Centre (SDGCC) in partnership with the United Nations Development Programme (UNDP) India, housed under the Swarna Jayanti Haryana Institute for Fiscal Management (SJHIFM). The SDGCC focuses on strategic coordination, data-driven insights, and collaborative action for sustainability in line with the global Sustainable Development Goals (SDGs).



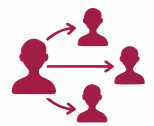
### **From Vision to Action:**

Creating benchmarks through SDG indicators, SDG Dashboard, Data Frameworks, identifying bottlenecks and strategizing to overcome them became a cornerstone of SDGCC's approach. The lack of a coherent platform for constant monitoring and evaluation was addressed through various indicator frameworks from state, to district and panchayat / ULB level, culminating in the development of district profiles and SDG indices. This fostered healthy competition among districts and empowered policymakers with real-time insights.



### **Empowering Stakeholders:**

SDGCC recognised that the success of the SDG journey relied on a shared understanding and commitment. Sensitising elected representatives and all department Nodal officers and key department heads was the first step. Going beyond numbers and indices, it was about how SDGs impacted the lives of common people and the pivotal role each stakeholder played.



### **Coordinated Strategies:**

Haryana, through SDGCC, charted strategic interventions aligned with every policy domain with a compass guided by the SDGs. The coordination translated into practical actions, including streamlined budget allotments, meticulous utilisation, and vigilant reviews. A collective effort of the government and stakeholders was instrumental in advancing sustainable development.<sup>03</sup>



### **Innovative Budgetary Push:**

One of the innovative strategies emerged in the arena of budgetary support and monitoring. SDGCC championed a push towards budget rationalisation, ensuring benefits reached the intended recipients, eliminating intermediaries, and introducing transparent, real-time monitoring mechanisms. The goal extended beyond expenditure to achieving impactful outcomes. Through SDG-aligned budget and Output-Outcome Framework Mechanism, this helped extend the focus beyond expenditure to achieve impactful outcomes.



### **Measuring Progress:**

SDGCC made a difference by developing progress indices for districts, departments, and SDGs. It shifted focus, moving from generic aspirations to time-bound targets, making SDGs concrete and measurable.



### **A Network of Changemakers:**

SDGCC didn't operate in isolation; it fostered a network of changemakers. Awareness programs, capacity-building initiatives, and data analyses of aspirational districts became tools to galvanise legislators, administrative heads, and government officials.

As Haryana strides forward, the journey is marked not just by numerical progress but by a sustainable, collaborative spirit nurtured by the innovative approaches championed by SDGCC.



# SDGCC – Strategic Actions

In August 2018, the Sustainable Development Goals Coordination Centre (SDGCC) became a key player in Haryana, functioning as a capacity-building hub, think tank, and knowledge centre.

## Action 1: Approach to Outcome-Linked Growth:

As the SDGCC unfolded its strategies, it addressed the concerns of key stakeholders. For the Chief Minister, it offered a blueprint to translate budget spending into tangible achievements. For the Additional Chief Secretary of Finance and Planning, it paved the way for outcome-linked growth, aligning outputs with long-term SDG indicators.

## Action 2: Consolidation and Clarity:

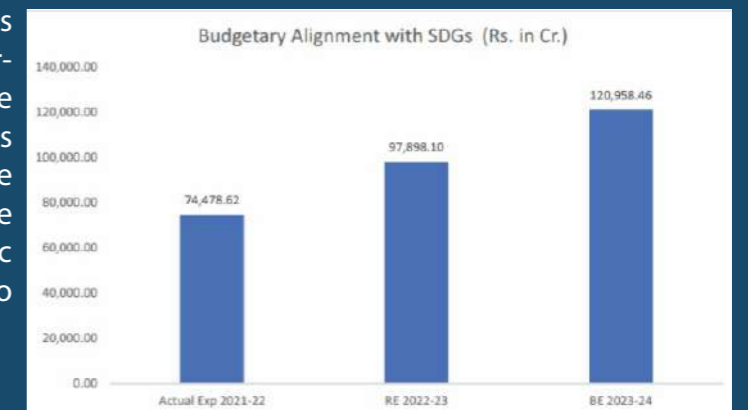
In the fiscal year 2022-23, SDGCC boldly consolidated 47 existing budgetary demands into 20, streamlining them under 8 thematic areas to improve interdepartmental coordination. This move ensured a focused, synergistic approach towards development. SDGCC redefined the game by shifting the focus from mere outlays to tangible outputs. Each scheme's outputs and outcomes were meticulously articulated during the annual planning process, steering towards real impact.

In the fiscal year 2023-24, SDGCC meticulously mapped both welfare and development schemes, along with recurring-in-nature schemes, to the pertinent Sustainable Development Goals (SDGs). This strategic alignment has led to an increased number of schemes being associated with the relevant SDGs, providing a comprehensive overview to bolster SDG-specific policy and program inputs in support of Haryana's VISION 2030. As a testament to this commitment, a substantial budgetary allocation of Rs. 120,958.46 crore under the Budget Estimates for FY 2023-24 has been earmarked in alignment with the relevant SDGs.



# SDGCC – Strategic Actions

SDGCC's consolidation of budgetary demands was a strategic move towards improved inter-departmental coordination. The next phase involves refining and strengthening this synergy, exploring innovative ways to facilitate department collaboration. This could involve cross-functional teams dedicated to specific SDGs, ensuring a holistic approach to development.



## Action 3: SDG Budget Alignment:

For the first time, Haryana aligned its SDG budget with plan schemes and non-plan (recurring) schemes. The SDG budget, a testament to this initiative, surged from Rs. 45,066 Crore (FY 2021-22) to Rs. 1,20,958 Crore (FY 2023-24), reflecting a commitment in financial figures.



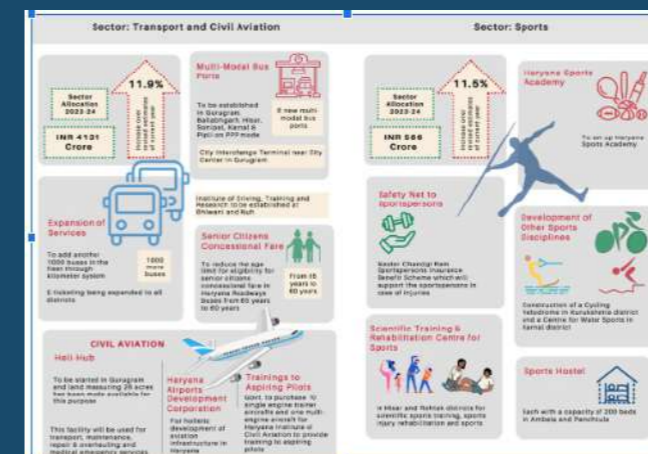
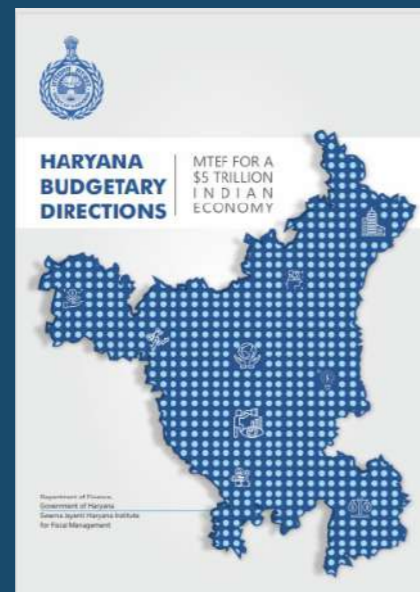
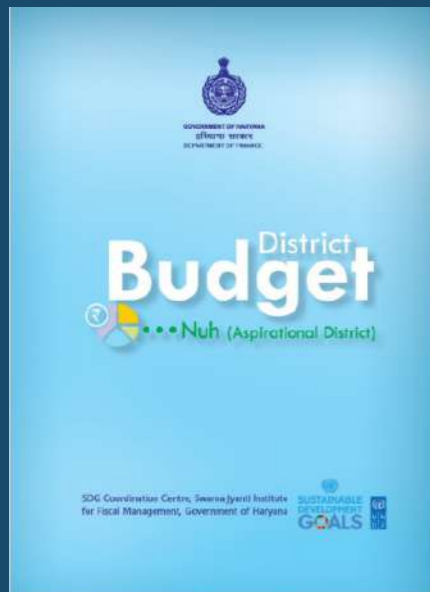
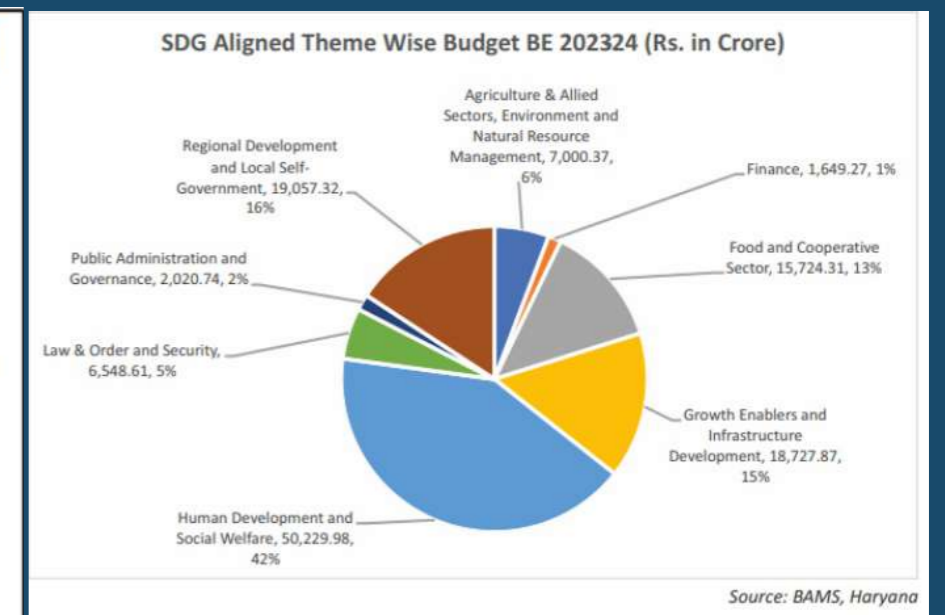
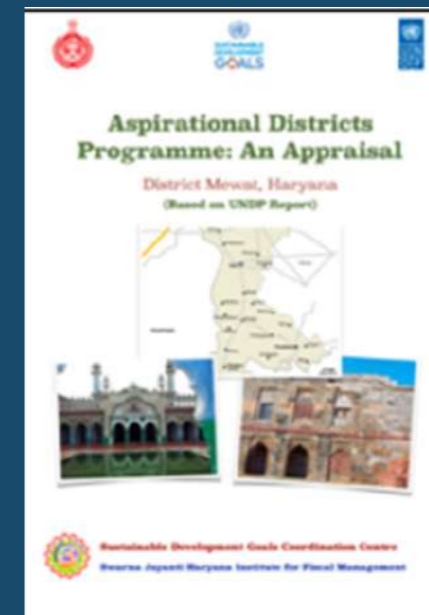

## Action 4: Navigating the NITI Aayog Framework:

Haryana pioneered the SDGCC model, and the NITI Aayog adopted it in the national SDG localisation framework. It transitioned from a state initiative to a national benchmark for harmonising development with sustainable goals.



## Action 5: Haryana SDG District Index Report

To establish a robust monitoring mechanism for tracking the progress of Sustainable Development Goals (SDGs) across districts in Haryana, SDGCC formulated three distinct SDG District Indices and Rankings. This initiative aims to foster healthy competition among districts, motivating them to strive for excellence in attaining SDG goals, targets, and indicators.

In addition, developed SDG District Profiles to enhance inter-department convergence within the district for effective implementation of Haryana's VISION 2030.

## Action 6: Indicator Frameworks at the Subnational Level

SDGCC established both a State Indicator Framework and a District Indicator Framework in alignment with the National Indicator Framework of 2022. This framework systematically maps the schemes and programs of state departments to the specific goals, targets, and indicators outlined in the Sustainable Development Goals (SDGs). In addition, established a Local Indicator Framework- Gram Panchayat.

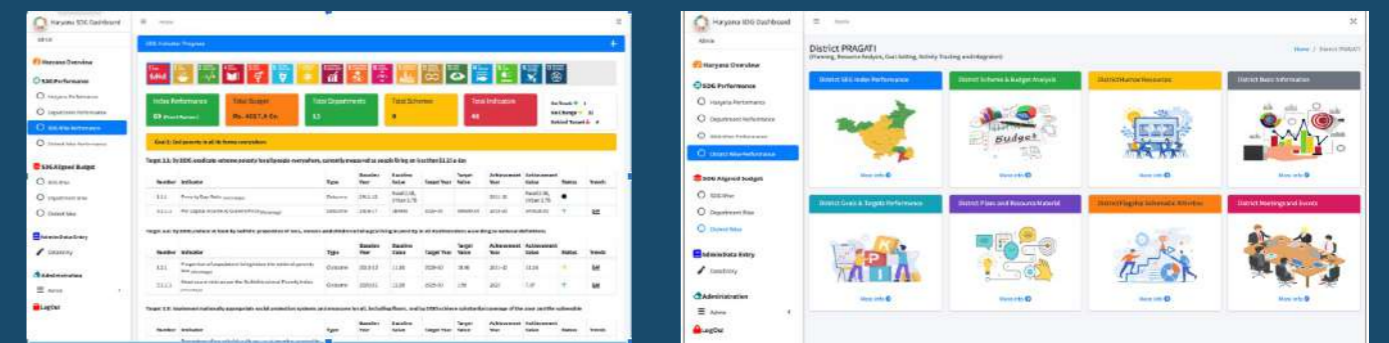

## Action 7: Digital Acceleration:

The SDG Dashboard and District PRAGATI App, (Planning, Resource Analysis, Goal-Setting, Activity Tracking and Integration) offered customised dashboards and dynamic reports to address the need for an integrated digital platform. The result was an evolved digital hub for monitoring and policy-level SDG decisions.

The digital acceleration witnessed through platforms like the SDG Dashboard is just the beginning. The future promises more sophisticated tools, integrating data from various sources, providing real-time insights, and facilitating evidence-based decision-making. The emphasis should be on making these tools user-friendly and accessible to all stakeholders.



## Action 8: Communication and Outreach:

Numerous innovative tools have been developed by SDGCC to facilitate communication about Sustainable Development Goals (SDGs) among diverse stakeholders.

## Action 9: Expanding Partnerships:

SDGCC's collaboration with UNDP and other stakeholders was instrumental. The future involves expanding these partnerships, leveraging the strengths of each collaborator. Engaging with the private sector, civil society, and academic institutions can bring diverse perspectives and resources, driving innovation and sustainability.

## Action 10: Workshops:

Understanding the importance of a "Whole-of-Society" approach, SDGCC organised events to sensitise elected representatives. Committees involving MLAs and ACSs were formed, becoming a helpful exercise in intensely understanding and monitoring the budget.

- In February 2020, an exhibition aimed at raising awareness about Sustainable Development Goals (SDGs) was organised, targeting legislators, heads of departments, and government officials.

- On February 19th, a successful workshop in collaboration with #armdigital, Gurgaon, was conducted to sensitise participants about Sustainable Development Goals (SDGs). Approximately 40 attendees took part in this workshop, and the content was well-received by all participants.

- Sensitization workshops were held for all departments on the State Indicator Framework and District Indicator Framework. Both reports were updated, including department mapping, baseline data, and setting targets for 2030.

As the global landscape evolves, building resilience becomes paramount. SDGCC's capacity-building initiatives should be developed to address emerging challenges and opportunities. This includes preparing stakeholders for potential shocks, fostering adaptability, and integrating sustainability into governance and decision-making.

## Action 11: SDG Alignment Reports and Conclave

Aligned Private Sector, NGOs, and Academia with SDGs through three documents: SDG CSR Linkage, SDG Academia Linkages, and SDG NGO Linkages. Orchestrated the SDGCC conclave in collaboration with the SDG Philanthropy Platform. Additionally, established the SDG First Networking Platform, a virtual exchange for deliberating on development issues.





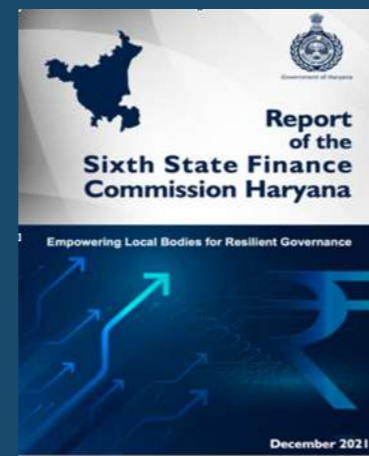
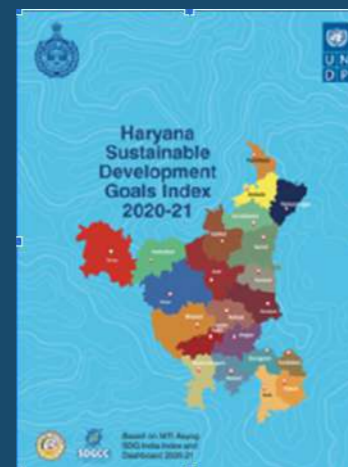

## Action 12: Impact on Governance and Progress:

The impact of SDGCC's strategies is reflected in Haryana's composite score, witnessing a remarkable 10-point increase from 2019-20 to 2020-21. The state leapt four positions in the ranking, from 18th to 14th. In addition, SDGCC also offered policy inputs to the Sixth State Finance Commission on the 'Role of Local Self-Government Bodies in Achieving the SDGs'.

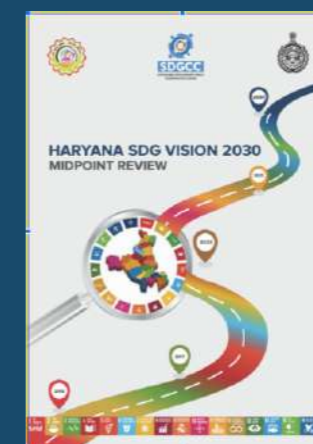


## Action 13: Vision to Action - Focusing on Sustainability:

Renewable energy share in the total installed electricity generation

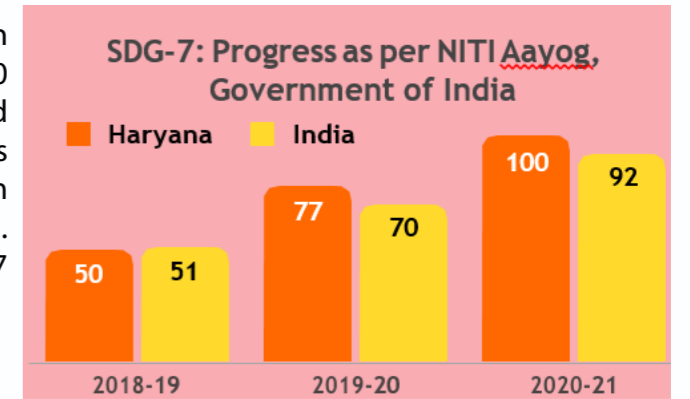

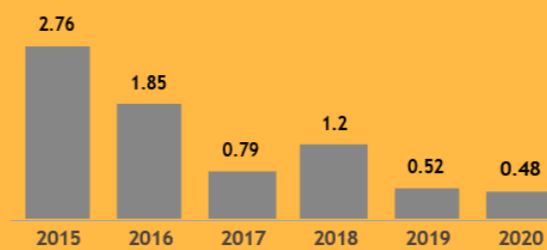

### Per Capita Fossil Fuel Consumption



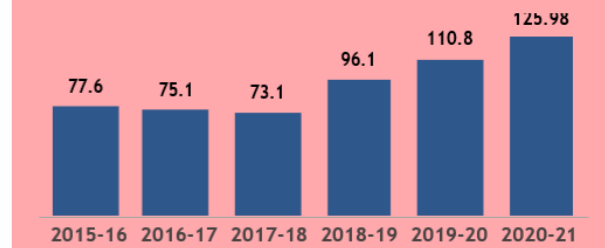

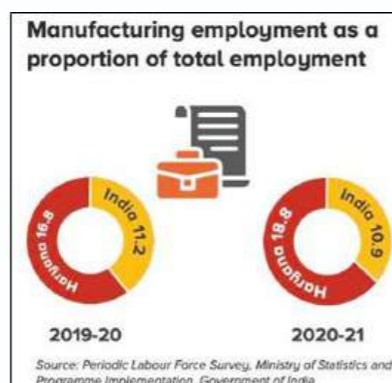

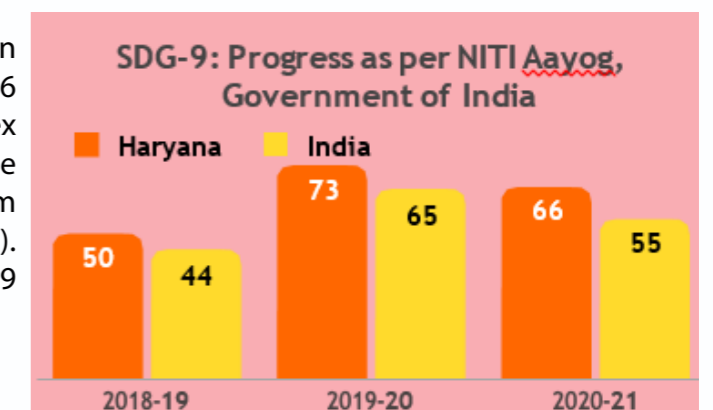
### Innovation score as per India innovation index
