### SDG India Index & Dashboard

India's flagship SDG monitoring tool has been the principal instrument for tracking the performance of its 36 States and Union Territories on their progress on the SDGs since 2018.

Popularly referred to as "India's Report Card on the SDGs", the SDG India Index uses 115 indicators to rank all States and Union Territories and place them into the category of Aspirant, Performer, Front Runner or Achiever based on their score.


